She stated that she wanted to talk to me and proceeded to start asking me questions, I then told her that I could not talk to her she would have to talk to my attorney. She then stated that she was not going to call the cops on me if I talked to her and that I would not call either and again started to question me, Again I told her that I could not talk to her and that she would have to talk to my attorney then I ended the call by hanging up the phone.

On 4/30/2008 at 8:13 am Ms. Harris called my work cell phone from a blocked number. She stated that Mike was in a serious crisis's at that point I asked what the trouble was that Mike was in. She stated that I wasn't her husband and I am not the kids' father and she was not going to tell me anything she said that she can't believe what I have put her and the kids through. She stated that she hopes I'm happy with my new family and thanks for a banding her and the kids. At this point I told her that I could not talk to her she would have to contact my attorney she then said that we were trying to force her into dropping the protection order and I told her that we were not trying to force her into any thing and as far as the kids I am completely available for a relationship with the kids. She then stated that the kids did not want anything to do with me and her daughter wants' to kick my girlfriends ass she then started to repeat her self with the same questions and I hung up the phone to end the nonsence.

On 4/30/2008 at 8:20 am Ms. Harris then called my work cell phone back from a blocked number I did not answer the phone.
