7-21-10 - I left my apartment - was on my way back when Kirsten came out of my apartment - met me in Amanda in the hall - started calling me some of above names ~~in~~ in my face (approx 1' away) raised voice - Amanda stopped in between & asked Kirsten to stop using such language - Kirsten told Amanda to "if you don't get out of my way you'll be leaving with a mark."

consistently 1" away from my face - yelling - "I oughta kick your ass" "~~of~~ (Olaura) 18 ~~mo~~ old

While I was holding ~~her~~ in my arms, in the my walker, Kirsten got in my face (approx 1") raised voice - "you piece of shit" "you will pay for this" (I told Kirsten I wanted her out of my home by the 31st of July)

7-16-10 I have been telling you (Kirsten) that I want you out by the end of the month. I don't see you doing anything about it" "you are here for a short period of time" Kirsten smiling "you're just an ignorant woman! you really think you can win!?! I know the system! you will not win!"

Kirsten refuses to resolve this issue of leaving/moving out of my home, consistently responding with "you won't win" "I'll move out when I'm fucking ready"
