DECLARATION OF THOMAS NOGLER  
IN SUPPORT OF DANA WALKER

My name is Thomas W. Nogler. I am over eighteen years of age and I am competent to testify in a court of law. I live at 1325 10<sup>th</sup> Ave. SE in Olympia, WA. I have personal knowledge of this case between Ms. Shawna Hawk and Mr. Dana Walker.

I met Ms. Hawk during a period when she lived with my brother Mr. Timothy C. Nogler. Timothy has stated to me during a period of Ms. Hawk's tenancy she alleged that Timothy had stalked her when he walked by his home to get the mail or take garbage to the street.

This was the basis for concern that I shared with Mr. James Mateson when Ms. Hawk expressed interest in joining the Board of Directors of Media Island International, a 501(c)3 organization. Mr. Mateson, who was the board president and founder of the organization, had been absent for fifteen years when he returned to Olympia and began to work with Ms. Hawk. During Mr. Mateson's work with Ms. Hawk, it became clear that Mr. Mateson and Ms. Hawk positioned themselves to organize a hostile takeover of the Media Island International Board of Directors.

An early action of Mr. Mateson and Ms. Hawk was to evict Mr. Dana Walker from the site of the organization. Mr. Walker had served as voluntary caretaker for the organization for four years. Mr. Walker is a journalist with an online newsletter where he publishes material not ordinarily posted in regular media outlets. This is the context of Mr. Walker's position towards Mr. Mateson and Ms. Hawk. Ms. Hawk and Mr. Mateson were engaged in a hostile takeover of the Board of Directors of Media Island. On the day of October 10, 2018, Mr. Mateson and Ms. Hawk voted to evict Mr. Fellows and myself off the Media Island International Board of Directors. A proper resolution of this case would be for Ms. Hawk and Mr. Mateson to vote Mr. Tom Nogler and Mr. Rick Fellows to the Board of Directors, followed by Mr. Mateson and Ms. Hawk's resignation from this board.

I swear under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct to the best of my knowledge and belief.
