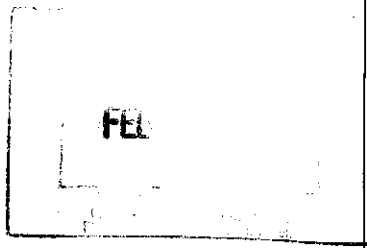

22 I, DIANE B. WEISSBURG, declare:

23  
24 1. I am an attorney at law duly admitted to practice before all the courts of the  
25 State of California and the United States Supreme Court. I am the attorney of record  
26 herein for Plaintiff/Creditor, Bree Walker-Lampley. I make this declaration based upon  
27 my personal knowledge and, if called to do so, could and would competently testify to  
28 the matter set forth below.

1           2. On January 31, 2012, Plaintiff/Creditor filed with the Court, and served upon  
2 Defendants, the following original documents in Adversary Proceeding: 9:11-ap-01253-  
3 RR, and Adversary Proceeding: 9:11-ap-01252-RR:

4           a. *Notice to Produce Original Transcripts and Produce Persons at Trial;*  
5           b. *Notice of Lodging Certified Copies of Transcripts for Trial;*  
6           c. *[Plaintiff/Creditor's Proposed] Pre-Trial Order;*  
7           d. *Plaintiff/Creditor's Witness List; Plaintiff/Creditor's Exhibit List;*  
8           e. *Declaration of Diane B. Weissburg In Support of Non-Receipt of Joint Pretrial*  
9 *Order from Defendants and in Support of Monetary Sanctions of \$3,500 (hereinafter,*  
10 *collectively, "Original Documents.") .*

11           3. Said Original Documents bore my typewritten signature in lieu of a signature  
12 by my own hand, with the exception of *Declaration of Diane B. Weissburg* which bore a  
13 signature by my own hand.

14           4. On January 31, 2012, the clerk of the Court issued a *Notice to Filer of Error*  
15 *and/or Deficient Document* with the following description: "The Documents Are Missing  
16 The Signatures by Paper Filer, THE FILER IS INSTRUCTED TO FILE THE PROPER  
17 SIGNATURES..." (hereinafter, "Notice.") The Notice refers the Original Documents,  
18 with the exception of *[Plaintiff/Creditor's Proposed] Pre-Trial Order*.

19           5. I became aware of the Notice on Friday, February 3, 2012 when I received  
20 same via U.S. Mail.

21           6. On Friday, February 3, 2012, at 3:50pm, a paralegal for my office, Jonathan  
22 Westwood, called the office of the Clerk of the Court to receive further instructions to  
23 cure the defect described in the Notice. During this call, the deputy clerk who answered  
24 the phone transferred the call to a person known to me as "Kam," whom I am informed  
25 and believe is the deputy clerk for the courtroom where the present action is assigned.  
26 Kam did not answer the telephone, and my paralegal did not leave a message.

1 7. On Monday, February 6, 2012, I personally visited the office of the Clerk of the  
2 Court to file pre-trial Motions in Limine, and to receive further instructions to cure the  
3 defect described in the Notice. I talked to "Kam" who stated I needed to talk to her  
4 supervisor to cure the defect. She gave me the telephone number for both of her  
5 supervisors, Ms. Clauson, and Ms. Davis. I waited approximately one hour after leaving  
6 a message on the voicemail for both Ms. Davis and Ms. Clauson.


7 8. On Monday, February 26, 2012, I personally spoke with a Ms. Davis, who I am  
8 informed and believe is the supervisor of Kam. Ms. Davis informed me that I may cure  
9 the defect described in the Notice by filing a declaration authenticating the Original  
10 Documents. I also left a message for a Ms. Clausen which has not yet been returned.

11 8. I hereby authenticate the Original Documents as originals, and attest that the  
12 absence of a signature by my own hand thereupon was inadvertent and a mistake.

13 9. By my signature on this Declaration, I affirm that The Court and all interested  
14 parties may use, refer to, and enter into the Court record the Original Documents as  
15 though my same signature were set forth thereupon.

16 I declare under penalty of perjury under the laws of the State of California and the  
17 United States of America that the foregoing is true and correct.


