Additional information: Shaelynn was not interviewed by Pretrial Services (PTS). However, PTS staff is familiar with Shaelynn due to his current supervision with this office. Shaelynn reports weekly to this office as well as TCSO for SOR reporting.

A violation has been filed for non-compliance with conditions of release on cause 20-1-52-34. There is concern with the nature of the weapons found on Shaelynn at the time of arrest on 20-1-948-3.

Recommendations: Release on cash/bond with PTS supervision is recommended.

- Release on Personal Recognizance
- Release on previously imposed conditions
- Pretrial Services supervision
 - Text reminders only
 - Alcohol monitoring device
 - Urinalysis testing
- Designated Crisis Responder evaluation prior to release
- Do not drive without a valid license, insurance & ignition interlock
- Cash / Bond
- Revocation of Conditions of Release
- Release not recommended
