DECLARATION OF PROSECUTOR
SUPPORTING PROBABLE CAUSE

JOSEPH F. WHEELER, Deputy Prosecuting Attorney for Thurston County, declares the following in support of probable cause for charges in the above-entitled cause:

I am a Deputy Prosecuting Attorney for Thurston County, Washington. I believe that there is probable cause to believe that the above named defendant has committed the crime(s) of ASSAULT IN THE SECOND DEGREE – DEADLY WEAPON/DOMESTIC VIOLENCE based on the following information from the official investigative reports:

On September 11, 2017, at approximately 0940 hours, in Thurston County, Washington, Deputy Kimball contacted Heather Lund in regards to a clear domestic disturbance. Heather advised that she had a physical altercation with her husband, Nicholas Lund, nine days prior. Heather stated she has been married to Nicholas for approximately six years. They have two children and all four live together. Heather and Nicholas both have anger problems and have had several domestic disturbances, which were reported in Pierce County. Both Nicholas and Heather have been arrested for domestic related crimes, and Heather stated she has PTSD from the past experiences.

On September 2, 2017, Heather had another domestic disturbance with Nicholas. The disturbance started as a verbal argument and Nicholas gave Heather some type of physical threat that upset Heather and brought back her PTSD. Heather became angry and her immediate response to the threat was to say, "Well I'll just kill you. Get the gun!" Nicholas became more irate. Nicholas walked away and came back with a small silver .38 caliber handgun. Nicholas waived the gun around and asked Heather, "You want to murder suicide this?" Nicholas pointed the gun at Heather as she was leaning on the couch. Nicholas walked up to Heather and pushed the barrel of the gun into the inside of Heather's right forearm. Heather feared for her life and she tried to pull away from Nicholas. Nicholas wrapped his arms around Heather and held her in place while she attempted to struggle away. Eventually Nicholas let go of Heather. Heather's mother, Diane Conatser, was in the hallway during the incident, protecting the children in the back bedroom. Once Nicholas let go of Heather she ran to her mother. Nicholas continued to waive the gun around and yell at Heather. Nicholas then went outside and left in a vehicle, taking the gun with him.

Heather claimed she had a bruise/welt on her right forearm from the gun barrel, but it was not obviously visible upon inspection. Heather was also adamant that the gun was loaded. According to Heather, the gun was always left loaded for home security. Heather stated she waited nine days to call law enforcement because she hoped Nicholas would get better and she did not want him to get in trouble. However, during the evening of September 10, 2017, Nicholas and Heather had another verbal argument. No threats or assaults were alleged this time, but during the incident Nicholas kicked Heather out of the house and would not let her back in. Nicholas also told Heather she would never see her children again. Heather walked around Yelm all night with nowhere to go. During the night, Heather spoke to a transient


1 who talked her into reporting the incident. On the morning of September 11, 2017, Heather decided it was
time to have this incident documented so she would not lose her children.

2 Nicholas agreed to meet and make a statement. He provided that he and Heather had a long
history of domestic disputes. On September 2, 2017, Nicholas and Heather had a verbal argument.
3 Nicholas left to calm down. A short while later, Nicholas received a text message and a photo from
Heather. The picture showed a pile of Nicholas' clothing, which was scattered on the ground outside.
4 There was also a bottle of bleach lying on the clothing. The text read, "For thinking u can fucking yell at
me." Nicholas called Diane and informed her of what Heather was doing. Nicholas begged Diane to go
5 talk to Heather and stop her from committing the same crime she was arrested for last time. Nicholas sat
down the street and waited for Diane to arrive. Nicholas saw Diane go by and he waited a few minutes
before he went to the house. When Nicholas arrived he saw his clothing was still lying in the front yard
6 with white bleach spots on them. Nicholas remained on the outside of the fence as Heather came out
on the porch. Nicholas and Heather had another verbal argument. During the heat of the moment Nicholas
7 stated, "This is why men beat women." Heather took a step back towards the front door and said, "I might
just kill you with your own gun." Heather had a smile on her face. Nicholas became even more upset and
8 ran around the fence. Nicholas feared that since Heather had smiled and took a step towards the door that
she might actually follow through with the threat. Nicholas said, "You're not gonna fucking kill me with
9 my own gun." Nicholas ran into the house and grabbed the gun in the kitchen. While in the house,
Nicholas noticed that Diane was in the back bedroom with the kids. Heather followed Nicholas into the
10 house. Nicholas grabbed the gun and held it by the barrel. Nicholas brought the gun up to his forehead
with such force that he accidentally struck himself in the forehead. Nicholas walked towards Heather with
the barrel pointed to his forehead still. Nicholas yelled to Heather, "If you're going to kill me, kill me in
11 front of our kids." Heather put her hands up and Nicholas walked closer to Heather. Nicholas began to
beg Heather to shoot him. Nicholas was so close he almost put the gun handle in Heather's chest, but he
12 was adamant he never touched Heather. Nicholas then pulled the gun away, with the barrel still in his
hand (the barrel was now facing the ceiling). At that time Diane came out of the back bedroom and saw
13 Nicholas holding the gun by the barrel. Nicholas turned around and walked out of the house. While
walking out the door, Nicholas heard Diane say, "Call 911." Nicholas spun around and said, "Call 911 on
14 me? She is the one threatening to kill me." Nicholas then got in his car and left.

Nicholas was adamant that there was no physical touching between him and Heather. Nicholas
15 was also adamant that he never pointed the gun at anybody but himself. Nicholas became upset when
Heather threatened to kill him, because she had threatened to kill him before. Two weeks prior Heather
16 threatened to slit Nicholas' throat while he was asleep. At first Nicholas did not believe the threat, but as
time progressed he began to believe it. For the last couple of weeks Nicholas had slept outside or in his
17 car to avoid Heather. When Heather threatened his life again he became more upset because he was tired
of being threatened. Nicholas also advised that he sold the handgun in question a few days ago to a co-
18 worker who was a long haul trucker. The trucker might not be in the area, but Nicholas stated he could try
and buy the gun back if he needed too.

Heather was re-contacted about the threat to slit Nicholas' throat two weeks ago. Heather said she
19 did say that, but she never actually intended on following through with it. Heather also admitted to putting
bleach on Nicholas' clothing. Heather advised that she started making the death threats to Nicholas in an
20 attempt to protect herself. Heather had been abused and threatened by Nicholas for so long, that Heather
felt if she made her threats more serious than his, he might leave her alone.



Heather L. Lund (35, fka: Conatser), her husband and 2 small children moved from Pierce to Thurston County a few short years ago. Neither liked the more rigorous rules of the DV game as practiced in Thurston by the authorities—especially when it came to DV involving loaded firearms, each threatening to kill the other, either by shooting or, as the Cupcake admitted, threatening to slit the husband's throat in his sleep. Their indifference to the fact their children and even the Cupcake's mother were present during these altercations was like water off a duck's back. That the Cupcake placed on the autism spectrum was no surprise. Thus her husband's argument she was a poster child of why wife beating should be made legal came across as insensitive at best. Neither the police, the husband's defense counsel, nor Prosecutor Jennifer Lord were impressed—especially as the Cupcake attempted to recant her earlier sworn affidavit submitted to the Thurston County Superior (Family) Court seeking a DV protection order and the seizure of her husband's firearms.



I genuinely appreciate your followup w/me in this matter. I sent a copy of my complaint to Jennifer Lord, the prosecutor who handled Mr. Lund's prosecution for DV and judiciously refused to provide Heather Lund a platform in court to perjure herself.

I was on the verge (reluctantly) of filing a petition for a protection against harassment and stalking order when I (as a last resort) blocked Heather's number from my Google voice service and her access to leave messages on the Mason County Blog. Since I executed those efforts, I've received no further contact from this woman I believe is exceptionally unstable and dangerous. I'd like to keep it that was as her husband (I believe) was earlier on a similar campaign to intimidate and harass me.

I feel the best practical antidote to abuse of free speech and modern communication technology is to use it to make the truth known and remove any/all anonymity of the offending miscreants. Toward that end, I have done so by publicly posting the phone messages Heather left on my answering service along with other identifying information including what I think is her picture on the posted article she takes exception to. I'm hopeful that this public declaration of her bad acts and identification will give her pause that she can and will be held accountable.

One aspect of all this I haven't told you disturbs me. After I filed my report with you and public notice I had done so, I discovered our mailbox had been stuffed with stolen mail from our neighbors residing on our route. I had checked our box for mail after dark on a Saturday and emptied it. The following day (Sunday Morning) on her (my wife's) way to retrieve our daily newspaper, she found our mailbox stuffed with the stolen mail. She took all of it and delivered it to the Shelton Postmaster's office on Monday along with an explanation of how it appeared in our mailbox. I cannot prove who did this, but found it unusual a mail thief would take care to place the stolen mail in a box along the route--especially ours. Unfortunately, ours has the word 'paralegal' emblazoned on its side beneath our house number. I am file attaching better fidelity audio files of the telephone calls Heather Lund left on my answering service along with the automated transcripts the Google voice calls messaging service provides.



Heather,

You are not the only one who has been threatened with a loaded firearm, thus not the sole source of my insight into the issue. Nor have you responded to my inquiries as to if you'd read the link to an article describing Elisa Tissot's murder at TESC or responded to my expressed belief you were telling the truth in your Petition for a protection order...a petition written in your own hand under penalty of perjury.

Your husband may have been under a lot of stress, been mentally (but not legally) ill, drunk, under the influence of drugs, or possessed by the Devil or simply feeling irritable and sleep deprived. None of those are defenses against a charge of DV. It isn't the 'papers' that make your husband "look bad" but the truth in your own words. Not only that, your husband admitted to the behavior in open court accompanied by his attorney and subjected to a colloquy by the judge before his guilty plea was accepted.

All of the stresses you suggest were mitigating circumstances go to sentencing, not the question of guilt to which he admitted wrong doing. Moreover, they don't meet the legal requirements for deviating from standar sentencing. Additionally, the principle of justice being SEEN to be done, protecting the public, protecting the children and you, and punishing the misconduct associated with a serious crime weigh against the mitigation you claim.

Nobody said your husband was a 'bad' person. But that doesn't mean he wasn't guilty of what he plead to. The core functions of government is to prevent force and fraud as well as provide for the national defense. You don't know me or my theory of government well enough to conflate my take on the BLM movement vs. ANTIFA. And it has nothing to do with your husband's guilt or innocence. Pointing a loaded firearm at anyone while threatening to kill them IS violence--domestic violence in this instance. That it may be an uncomfortable truth doesn't alter the fact of the matter.

The prosecutor (Jennifer Lord) could and should have been more solicitous of your input, but she is not bound by it and had a duty to others besides you as I've explained. I see no misconduct on her part in this instance. Given the guilty plea, there is no right of appeal. Part of being an adult is accepting responsibility for your actions. I do not fault you for petitioning the court for protection under the circumstances you described. I do not fault your husband for pleading guilty to and accepting responsibility for his egregious misconduct he admitted to. I don't think your argument against the attorneys or the judge is compelling. Nevertheless, I support your right to tell your side of the story after the fact and ill endeavor to make that possible should you choose to do so. Parenting, marriage, guns, self discipline, and respecting the rights of others are all serious responsibilities though not always gratifying.

You seem more than a bit defensive here and I admit I have you at a disadvantage having lived much longer and experienced more. In that light and the hope that illustrations are windows to understanding (again, read the link to Elisa Tissot's murder) allow me to share the following true story with you:

Many years ago, my previous wife and I settled on the Duckabush (near Brinnon) having purchased a 22 acre farm there. A small general store w/gas pumps was the only source of groceries in that corner of Jefferson County, WA. A man named Dale had purchased the store under unusual circumstances (along with surrounding waterfront land) with \$50,000 he'd saved running a Seattle bar he allowed to be used for drug transactions. (I learned this by way of pillow talk from a mutual girlfriend.)

The previous owners were a married pugnacious couple in their 50's who'd get on the CB radio to insult any hippies on Hiway 101 and tell them they wouldn't be served should they stop for food or gas. As it so happened, they were both gun fanatics, got into an argument about what channel the TV was tuned to one evening and turned to violence to settle the matter. The man got his pistol and struck his wife with it. She, in turn, went into her bedroom to retrieve her sidearm. They confronted each other at gunpoint in OK Corral fashion. He shot her in the chest 5 times while she only managed to plug him 4 times, but her cluster was tighter. He died while she survived an emergency airlift to the Harbor-View Trauma Center. She had little interest in running the store after that, so Dale got a steal given the true value of the property since he had cash. This was in the mid-70's.

Moral? Guns and DV don't mix. I'm relieved nobody got shot under your circumstances. You do your husband no favor by trivializing the event. While there's no certainty you'd have been shot, we lock up drunk drivers for less. Pointing a loaded firearm to threaten a person IS assault and, because he's your

husband, DV. There's no way to beat around the bush and BLM has as little to do with it as whether I mow my lawn.

PS: BLM seized on the death of George Floyd to organize protests over endemic police brutality, disproportionately experienced by Blacks across America. Many people of conscience in good faith joined these protests. Typically, populist movements become hijacked by political outliers. BLM was no different in that respect. But it is ANTIFA that originated almost a century ago in Europe as the creation of Leon Trotsky, the Soviet propaganda minister, Marxist intellectual, and leading theoretician to counter the NAZI street toughs--both totalitarian philosophies. I know this by way of my experience as a very young man with the Trotskyites in S. California before your parents even met when they lured me to a forced political indoctrination camp 100 miles north of San Francisco and threatened to literally drag me to the classes while I was in a severely sleep deprived state. I also went to UCSD w/Angela Davis and knew Herbert Marcuse, one of her professors on campus. 


