My name is Pamela Anglemyer. I am over the age of 18 and competent to testify in a court of law. I reside at 531 E Wood Ln, Shelton, WA 98584

I currently rent a room from Robert Charleston where I have resided for approximately one year now. I moved in shortly after Bob's wife passed away last December. I pay monthly rent in addition to assisting Bob with housekeeping and preparing his meals. We have excellent and friendly relations and get along very well. I enjoy helping Bob and he says he likes my cooking.

I have known Tim Mallea for about 14 years. He is my former brother-in-law. He was previously married to my baby sister. My sister and her disabled children stayed with Bob for a short while in December. Bob needed an engine replaced on his Toyota Camry, so I suggested he ask Tim who I believed to have skills in mechanics to do the work. Tim came over shortly after Christmas to work and Bob invited him to stay on the couch in exchange for the work.

I feel Bob bent over backwards to help Tim. While Tim was here he did just enough work so Bob wouldn't get upset, after which he would leave until late at night and not return until after we were asleep.

One day I heard Tim comment while walking out to work on the car, "If anyone tries to steal from me, I'll send some of my friends out to visit them and I might come too." I laughed it off at the time but now take it seriously and consider it a threat, which frightens me.

Tim repeatedly said sexually crude things to me, teasing me about my body, that made me feel sick. Bob complained to me for a week because Tim showed him a graphic picture of Tim's girlfriend who looks very young. Bob said it was disgusting and was very angry about it.

Tim brought his girlfriend over and Bob told him no women could stay here with him.

Tim accused Bob of sexually harassing me which is not true. Bob has never sexually harassed me. I know Tim is a registered sex offender. I was told it was because he dated a girl when he was a teenager and her parents turned him in to the police.


Tim piled all of his belongings into Bob's carport without asking permission and expected Bob to take care of it all for him. Bob didn't know whose belongings they were, showed me the pile, and asked me what it was. Tim moved all his belongings from the carport into Bob's car where it remains. We can't take it out because Tim took the key.

We recently received in the mail a cell phone with Bob's address on it for Tim. I wrote on the package that no one by that name lives here and Bob returned it at the Post Office. We received other mail for Tim also.

Tim continues to send me text messages. He repeatedly asked if his cell phone arrived and when he can come get it. He wrote that he is sleeping outside in the cold with wet clothes and "frozen like a pop sickle." I do not want him to contact me any more.
