PETITION TO ESTABLISH ORDER OF CHILD SUPPORT (Not A Mandatory Form)

I. BASIS

#### 1.1 CAUSE OF ACTION.

This action is brought pursuant to RCW 74.20.220 by The State of Washington, Department of Social and Health Services, petitioner, through the Mason County Prosecuting Attorney to establish a child support order for

Camdyn Keith Dobbs, 5 weeks, residing with mother, in Mason County, Washington.

## 1.2 ACKNOWLEDGMENT OF PATERNITY.

Cody Sterling Dobbs is the child's acknowledged father and Sara Rose Martin is the mother of the child. Both parents signed the Acknowledgment of Paternity, which was filed with the Washington State Registrar of Vital Statistics on April 28, 2011.

A copy of the Acknowledgment of Paternity is filed with this petition.

#### 1.3 JURISDICTION.

The court has jurisdiction over the parties because:

The mother presently resides in the State of Washington.

The acknowledged father presently resides in the State of Washington.

The mother and acknowledged father engaged in sexual intercourse in the state of Washington as a result of which the child may have been conceived.

# 1.4 PETITIONER'S AUTHORITY TO INITIATE ACTION

Petitioner is authorized to initiate this action to obtain a support order for a dependent child on whose behalf it is providing public assistance or support enforcement services pursuant to RCW 74.20.220.

#### 1.5 MINOR PARTIES.

The Acknowledged Father is a minor for whom a guardian ad litem should be appointed pursuant to RCW 4.08.050

#### 1.6 CHILD SUPPORT.

Child support and health insurance coverage for the minor child has not yet been determined.

## 1.7 REIMBURSEMENT.

The state of Washington is entitled to reimbursement for support or assistance provided to the child and for expenses incurred on behalf of the child.

#### II. RELIEF REQUESTED

The court is requested to enter an order that:

determines support for the dependent child pursuant to the Washington State Support Schedule and requires either or both parents be ordered to maintain or provide health insurance coverage for the child and pay extraordinary uninsured costs proportionate to their income.

orders the acknowledged father to pay past support, medical, and other expenses incurred on behalf of the child.

awards court costs, guardian ad litem, attorney, and other reasonable fees.
