Considerations for Virtual Hearings:

Virtual hearings are just like attending court in person. Required:

- Dress appropriately;
- Mute your microphone unless you are asked to speak;
- Follow the judicial officer's stated rules or risk being removed from the hearing;
- You can only attend one virtual hearing at a time, please contact the court if you are scheduled to appear in multiple hearings.

If Possible:

- Check your lighting and background before court;
- Avoid moving your video or making quick movements;
- Find a quiet space.
