The Court/clerk/administrator erred by failing to hear/call this duly, timely noted motion for reconsideration on 12-10-21 @ 10:00am. No effort to correct the error was made by the judicial assistant (Pier) to judger Schaller, the Clerk, or the Administrator desite my alerting each of them in the face ofunanswered calls and e-mail--a denial of access to the court and due process.

Case 21-4-00452-34 was noted for the same purpose constructively on 11-12-21 a few minutes after 5:00pm because of an intyernet outage that delayed the electronic filing. I was given n o opportunity to bring this to the attention of the ourt at all, or the misconduct of the petitioners and the interference by the Clerk's and administrator's staff.

The Court misinterpreted Roberts vs. Robers and erred in declaring there was no ambiguity along with ignoring the Memo argument commissioner Thoma had declared I had filed a Motion to Revise and denied my motion for reconsideration on tyhat basis, thus prejudicing my efforts yet again. I relied on) Thomas, equitable & njudicial estoppel which bars the court contradicting itself to my detriment. Similarly, "within" is understood to often mean "no later than"--e.g. '...within a fornite , an act must occur' doesn't preclude the demand being met earlier than that when it prejudiced no one by its prompt filing. The court itself exceeded the 60 day maximum imposed by RCW 11.132.225.to enter a ruling.)
