While there are housed community members with childcare experience that Selena can call upon to babysit the kids, she rarely takes a day off, spending all her time caring for and nourishing her family. The kids have plenty of toys - spending just one evening with them recently I found them drawing, swimming in an inflatable kiddie pool, helping mix ingredients to bake a cake, blowing bubbles, and watching Finding Nemo. They love their mother, and often refuse to sleep unless they know she is nearby.
