PETITION FOR ORDER ADMITTING
WILL TO PROBATE, APPOINTING
PERSONAL REPRESENTATIVE,
ADJUDICATING SOLVENCY AND
GRANTING NONINTERVENTION
POWERS

TO: THE HONORABLE JUDGE OF THE ABOVE ENTITLED COURT

The petition of KATHRYN L. STOKER shows to this court:

1. **Petitioner.** Petitioner, KATHRYN L. STOKER, a resident of Olympia, WA, Thurston County is the step-daughter of MARIE C. WARREN, deceased, and is the personal representative designated in the decedent's Last Will and Testament.

2. **Jurisdiction.** The decedent, MARIE C. WARREN, died in Thurston County, WA on the 17th day of October, 2015, being at the time of her death a U.S. citizen and a resident of Thurston County, Washington leaving an estate subject to administration. Petitioner is a resident of Thurston County.

3. **Notice.** All notices required by law will be given.

4. **Testacy.** The decedent, MARIE C. WARREN, died testate, having executed her Last Will and Testament dated the 19th day of December, 2014, in



1 the presence of two competent witnesses, who, at her request and in her
2 presence, and in the presence of each other, subscribed their names as
3 witnesses to said Will and in whose presence she signed the same and to whom
4 she declared the same to be her Last Will and Testament. At the time of
5 executing her Last Will and Testament, the decedent had obtained the age of
6 majority and was of sound mind. The Last Will and Testament is submitted
7 herewith along with the witnesses' affidavit to the execution of the same.

8
9 **5. Solvency.** The net value of the decedent's estate is estimated to
10 be in the excess of One Hundred Thousand Dollars (\$100,000.00). Assets are
11 believed to exceed liabilities.

12 **6. Surviving Spouse.** The decedent died leaving no surviving
13 spouse.

14 **7. Heirs.** The decedent left surviving as her heirs, devisees and
15 legatees as identified in the Will as the following:

23 **8. Nominee.** KATHRYN L. STOKER is decedent's Step-Daughter
24 and is the person appointed personal representative in the decedent's Last Will
25 and Testament.

1 **9. Bond.** Bond requirements should be waived pursuant to the
2 direction in the decedent's Last Will and Testament paragraph Fifth.

3 **10. Nonintervention Powers.** Nominee should be granted
4 nonintervention powers pursuant to the direction in the decedent's Last Will and
5 Testament paragraph Fifth.

6 WHEREFORE, the undersigned, KATHRYN L. STOKER petitions
7 the court for an order as follows:

8 **11.** Admitting the offered Last Will and Testament to probate and
9 adjudicating that the decedent died testate;

10 **12.** Adjudicating the estate to be solvent;

11 **13.** Appointing KATHRYN L. STOKER as personal representative of the
12 estate with non-intervention powers;


13 **14.** Directing the Clerk of the Court to issue Letters Testamentary to
14 KATHRYN L. STOKER.

15 **15.** Granting the Personal Representative, upon filing of her Oath,
16 nonintervention powers and directing the Personal Representative to complete
17 administration of this estate without further intervention of the court;

18 **16.** Directing that the Personal Representative to serve without bond; and

19 **17.** Authorizing the Personal Representative, upon filing of her Oath, to
20 transfer all property of the estate without further order of the court.
