TESTAMENTARY AND GRANTING
NONINTERVENTION POWERS

THIS MATTER having come before the undersigned Judge/Court
Commissioner upon the petition of KATHRYN L. STOKER, by and through her
attorney, MARTIN D. MEYER, and the court having heard the presentation of
counsel and being fully advised in the premises, NOW, THEREFORE, IT IS
HEREBY

ORDERED, ADJUDGED and DECREED as follows:

1. It is adjudged that decedent MARIE C. WARREN, died testate in
Olympia, WA on October 17, 2015; that the offered Last Will and Testament
dated December 29, 2014 was executed and witnessed in the manner prescribed
by law and is hereby admitted to probate as the Last Will and Testament of
MARIE C. WARREN, deceased. The testimony of the witnesses to the



1 decedent's Last Will and Testament of the above-named decedent was
2 presented in open court and reduced to writing.

3 2. The estate is adjudged to be solvent.

4 3. MARIE C. WARREN, decedent's Step-Daughter, is hereby
5 appointed Personal Representative of the Estate of MARIE C. WARREN.

6 4. THE CLERK OF THE COURT IS DIRECTED to issue Letters
7 Testamentary to KATHRYN L. STOKER upon her taking and filing of her oath
8 required by law.


9 5. Upon filing of her oath, said Personal Representative is hereby
10 granted nonintervention powers, shall serve without bond, and shall complete
11 administration of said estate without further intervention of this court consistent
12 with her duties as Personal Representative. KATHRYN L. STOKER, as Personal
13 Representative of the estate, is authorized without further order of this court to
14 transmit to transfer agents and to register for change of registration and to have
15 transferred and to have registered and to convey and distribute any and all
16 stocks and bonds standing in the name of the deceased and to transfer any other
17 property of the deceased, and that from and after the making of this order the


Personal Representative shall have the power to transfer any and all real property of the above named deceased and otherwise conduct all matters of decedent's estate without further order of this court.
