2. I declare: A NEED FOR A TEMPORARY VISITATION  
ORDER (SEE ATTACHED)

THERE IS NOTHING IN THIS WORLD MORE IMPORTANT THAN FAMILY. IT IS DIFFICULT TO BELIEVE ANY MEMBER OF A FREE SOCIETY WOULD BELIEVE ANY DIFFERENT. I HUMBLY ASK THIS COURT TO GRANT ME VISITATION WITH MY CHILDREN. IF ONLY ON WEEKENDS UNDER THEIR GRANDPARENTS SUPERVISION. THE COURT MAY RECALL THAT IT WAS I WHO SOUGHT PROTECTION FIRST, I SAW THIS COMING. THEIR MOTHER RETALIATED WITH AN ORDER OF HER OWN KNOWING FULL WELL THE COURT WAS SUSCEPTIBLE TO HER MANIPULATIVE LIES AND CONSIDER THAT THE MALE, THE CHILDREN'S FATHER, WAS THE ABUSIVE PARTY. GIVEN THE HISTORY OF MEN, I CAN SEE HOW EASILY THE COURT COULD BE SWAYED TO BELIEVE THIS IS TRUE. I AM A FATHER. AS SUCH I ACCEPT THE RESPONSIBILITY TO RAISE THESE CHILDREN. TO BE THEIR PROTECTOR, AND THEIR EDUCATOR. TO TEACH THEM THE DIFFERENCE BETWEEN RIGHT AND WRONG. I HAVEN'T SEEN MY BABY GIRLS FOR SEVEN MONTHS NOW. MY LAST MEMORY OF MY OLDEST BABY GIRL WAS HER REACHING OUT TO ME OVER HER MOM'S SHOULDER CRYING AND SCREAMING "DADDY!". AS HER MOTHER PUT HER IN HER FRIEND'S CAR AND TOOK HER AND HER LITTLE SISTER AWAY. THIS COURT DECIDED THAT I WAS THE ABUSER NO MATTER HOW MUCH I BEGGED TO DIFFER. NOW, CPS HAS CAUGHT UP WITH SELENA SMITH. FROM WHAT I UNDERSTAND THEY HAVE DECLARED

SHE IS UNFIT TO CARRY ON HER PARENTAL DUTIES. I HAVE NEVER MEANT SELENA SMITH ANY HARM. I KNOW SHE WAS UNHAPPY WITH THE FAMILY SITUATION SHE HAD FOUND HERSELF IN. SHE LEFT US AND THE CHILDREN AND I DID JUST FINE WITHOUT HER.

THE CHILDREN'S GRANDPARENTS PROVIDED US WITH A FAMILY HOME. WHEN THIS COURT DECIDED THEIR MOTHER WAS ALRIGHT TO DO WITH THEM AS SHE PLEASED THAT HOME WAS NO LONGER AVAILABLE TO ME AND I WAS ASKED TO LEAVE. THAT HOME WAS MEANT TO PROVIDE A SAFE SPACE FOR THE CHILDREN. WITHOUT THE CHILDREN IT DIDN'T MAKE ANY SENSE FOR ME TO CONTINUE LIVING IN THEIR HOUSE. COVID19 CONTINUES TO INHIBIT ME FROM RETURNING TO WORK AND I DO NOT YET HAVE A CONDUSIVE RESIDENCY FOR HARBORING AND RAISING CHILDREN. EVENTUALLY I WILL PROVE TO THE COURT I AM CAPABLE OF CARING FOR THESE CHILDREN ON MY OWN, BUT FOR NOW I ASK THAT THEY NOT BE SERERATED FROM BOTH THEIR PARENTS. I DON'T WANT THEM FEELING ALONE AND ABANDONED. THEY ARE SO VERY YOUNG AND I LOVE THEM SO VERY MUCH. PLEASE GRANT ME A TEMPORARY ORDER TO VISIT WITH THEM AT THEIR GRANDPARENTS. IF ONLY FOR THE WEEKENDS. UNTIL I CAN RETURN TO WORK AND ESTABLISH A LIFE ON OUR OWN. FAMILY IS THE MOST IMPORTANT THING.
