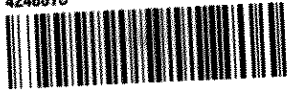

2. On the 15th day of November, 2018, I caused to be deposited in the United States Mail, postage prepaid, by regular first class mail, copies of the following:


