I also request temporary surrender all firearms, other dangerous weapons, and any concealed pistol licenses without notice to the other party because irreparable injury could result if an order is not issued until the hearing.

What irreparable harm would result if an order is not issued immediately without prior notice to the respondent?
 I need all stalking and harassing behavior to stop. The heavy drinking, combined with his anger, and insinuations/suggestions, both recent and past, that he may have to defend himself against me by shooting me, or that women like me that end up dead does not bother him in the least, and other comments and behavior, where he suggests lies and fabrications that would justify my harm, is not only threatening, but something I take seriously. There are too many threats and aggressive behavior circulating in the family and circle, and my children and I need legal protection and safety. Hopefully, this will help check his and other's behavior, and posit some semblance of civility among all parties. At the root of it is alcoholism, heavy drinking, aggressive male tempers, gums, ego and violence. It is untenable for my children or I. All of us have been assaulted. Sometimes other men are allowed to do it. Sometimes he does it. This includes the children. I am here to stop it.

11/23/2020 - harassed by a "Billy York" through FB messenger, semi-threatening, intimidating, suggestive but indirect, implies I should give up, shut up, there could be violence, my autistic daughter should go to my mother, I should give money so she can be cared for, I'm a bigot, an evil woman, abusive to men. He admits to being associated with the Rainbow Family of Living Light. I recognize him. Jim and Jim's friends know him. I've seen him before. He implies he's spoken with the couple who sold me my minivan recently, and I can drive it into a lake.

11/18/2020 - Jim grabs me by the wrist while picking up the living room and violently twists my arm and assaults me I am able to finally leave after an hour. I get my children and my friend comes and gets us, and lets us stay with her.

11/10/2020 - I'm forced off the road by a group of trucks who block me in on all sides while traveling home.

11/06/2020-11/08/2020 - I'm harassed by a group of trucks for hundreds of miles on remote roadway late at night. They stop when I stop. No matter where I go they follow. When I decide to drive back (quite a distance) to where I started, they turn around and

follow me all the way back. It is very frightening. During this same period, at another time, I am tailed by a vehicle with a Deadhead sticker, which I photograph, and I drive to a public place for safety, where another rogue 911 call is placed on me and I am harassed.

10/31/2020-11/08/2020 - a series of rogue 911 calls are placed to police (false reporting) resulting in my harassment using police

10/25/2020 - I'm harassed at an event I'm at and then hit from the side by a driver who totals my car. I don't know if it's related.

He was drunk. But in each of the events where I was harassed in my vehicle, the men who got out had obviously been drinking and were drunk. And this incident happened directly after I was harassed at the event I had left and he didn't even attempt to brake.

My car skidded 15 feet, but I was wearing my seatbelt and was ok.

10/21/2020 - I leave on business, but my partner knows I want to leave him. He has been verbally abusive to me for weeks and forced sex on me.

Describe the past incidents where you experienced violence, where you were afraid of injury or where the respondent threatened to harm or kill you: _____

My partner began abusing me 3 weeks after we began our relationship when his friends came to stay with us. It began verbally. I didn't like it and was shocked by it, because it had been very beautiful up to that point. His male friend was rude to me first.

But after they left, he kept it up. I tried to suggest diplomatically we should end it. But he did not want that. It continued, and I tried

to leave. He pulled me to the floor and laughed while I struggled to get away, on top of me, holding me down while I screamed and tried to claw my way towards the door. This happened many times. It was continuous for two years. I was taken down physically to

the floor many times and wrestled and wrenched, constrained, while he laughed and mocked me. My first birthday together with him was the worst, because he forced sex that hurt me, I cried and he wouldn't let me go. All his friends, who were there, ignored my

calls for help. He claimed later not to remember. After conceiving our first daughter, he punched me so hard in the jaw after I told him I didn't think he loved me, I couldn't open my jaw for weeks. At friends houses or in private, I was physically assaulted and could

expect no help, only blame. He stopped physically assaulting me after I became pregnant. I stayed pregnant or nursing for two years.

But he would kick or damage my property. His friends intimidated me. I befriended a woman in the circle, who helped me. She went missing and still is. When I ran away with our baby after he hurt her and me, and having learned her partner, his good friend, was

suspected of murdering her, I was tricked into leaving her and then blackmailed into entering an institution if I wanted to see her again.

This is how I had to give up breastfeeding her. They claimed I was crazy after that. His friend suspected of murder had intimidated

me too. He later tried to sexually assault me after Jim had him stay with us, and I had to physically fight him off. His other friend, who tricked me, later assaulted me and my children, and one of them, I'm not sure which, drugged me without my consent. Jim admitted to

a CPS appointed counselor later to slipping drugs into my coffee without my consent. He's admitted to hurting me to others.

He has sexually, physically, emotionally and verbally been abusive to me extensively, and what I have recorded here is hardly exhaustive. He lets his male friends participate in it or try at it. They seem to think it's fun, challenging or entertaining. For me, it was continuous stress and a lot to survive. I am telling the truth. I am not lying. There is supportive evidence. But there is a lot that has occurred and that the children and I have lived through. He has threatened to shoot me or murder me or make my life hell if I don't cooperate, in essence, or leave him. He blames me. He demonizes me for taking the children, and destroying our family.

10/07 - recovering from carbon monoxide/smoke inhalation at home after returning from work assignment with the Census. Raven, the baby, has severe diaper rash, the house is trashed.

10/11 - still at home

10/13 - spend \$400 cash at Fred Meyer to restock house with food

10/16 - I leave for a night after Jim has been drunk and verbally abusive with me for days, justifying it by saying I'm not helping/doing enough. I'm still recovering from lung injury and having trouble.

10/19 - I was making beautiful dinners back at home, trying to appease Jim and brighten his mood, making enchiladas and Indian food. I redouble my efforts to keep the family together and him happy.

10/21 - despite my best efforts, Jim isn't happy, he's run out of alcohol and is very irritable and abusive. I leave. I'm still not doing well. I have plans to meet with Congressman Denny Heck in Washington DC, meet with old coworkers about employment enroute, and do some freelance reporting work. Jim knows I'm exploring moving on with my life. Jim has been drunk and mean all month. I'm very stressed. Nothing I do is working. My health is getting worse, not better. I'm exhausted. He's run out of money to buy alcohol with again. I've watched him lose his temper with my daughter Hazel and be overly harsh in disciplining our two year old.

10/25 - I stop at George Floyd Square in Minneapolis, MN on my way to do some light reporting, pay my respects and donate food. While there, I experience breathing problems and weakness. A street medic there identifies with their equipment I'm suffering from an erratic heartbeat. Arrhythmia. I have to stay and rest for some time. Some people show up late none of us know and start fanning smoke from the fire in my face at the medic's tent where I'm resting and begin to get aggressive. People present mitigate and I exit. As I'm driving out of Minneapolis, a man hits me from the side in his vehicle and totals my car. The next day I am able to get a rental. But my trip is over and I learn I will have to travel home and then back to Minneapolis to deal with insurance and the situation.

10/29 - I arrive back home, and gather the title, documentation and other material I need for insurance to pay me out on my vehicle. There are no charges or tickets I have incurred, the other driver was drunk, but Covid is delaying matters and I need transportation and to facilitate the process.

10/31 - a rogue call was placed to 911 in Wenatchee, WA, where I stopped to rest for a minute after getting gas, before continuing East in my travels, the officer disclosed it was reported I was swerving and driving erratically, without my lights on, reported as a DUI. In fact, this was not the case. I was swarmed by police officers after getting back on the road and heading for the main hwy.

11/2 - took pic of a potential property near a college I'm interested in and learning about the Native American community there

11/06 - tailed by vehicle with DeadHead sticker, Henderson, WI, 9:33pm before pulling into Denny's parking lot and eating and retiring to vehicle to rest for night. A rogue call is placed to police, and I am harassed.

11/08 - harassed by group of trucks WI for hundreds of miles on remote roadway. I finally make it to a more populated public area where they disband.

11/10 - forced off road by group of trucks on remote roadway, who place a call to police reporting me as a DUI, and I am arrested on suspicion of such. Sheriff Tom Boyer releases me

after inquiry, and all charges are dropped. It was a rogue call, and there is no evidence I was driving under the influence. The sheriff expressed concern my civil rights were being violated. 11/11-11/12 - released late 11/11, all charges dropped, property restored. I went to look for my password book, which had all my passwords for everything from my bank accounts to my email, google, etc. I discover my password book is missing. I make it home late 11/12. I never find my password book at home. Normally, it's always in my purse. Just before making it home, my friend calls me, and I learn her adopted adult daughter has been murdered. When I get home, I tell Jim. He looks me dead in the eye, and tells me it's a good thing when evil women die. He is suggestive and hateful the way he looks at me, and tells me he really doesn't care. Jim has threatened my life before, including with suggesting he might have to shoot me, and I am very uncomfortable.

11/18 - Jim, drunk, violently twists my arm and assaults me while I am cleaning the living room. I call my friends, who come and get me and the kids.

11/20 - went with Scott to take picture of VIN on the vehicle I purchased, we remove plates, and leave

11/21 - returned to house, with a friend accompanying, there's a police incident. Jim won't let anyone in the house, not my mother, myself, the kids, anyone. The police tell him he can't do that and leave. He promises to be civil. Once alone, he gets suggestive about a broken window in the house that's been that way since we moved in, unrepaired, stating how the police told him if I wanted to break a window to get in, I could. While looking for things, I find some mail hidden away, and in it is a child support case Jim has filed against me. He applied for cash from the state for himself and the children, despite the fact is been carrying food stamp benefits for myself and the kids for a year and been providing for all our needs. When I ask him about it he's angry, and accuses me of going through his mail. I point out it's addressed to me, and ask why he hid it from me. He gets angry and doesn't want to talk to me. It's apparent I no longer will have food stamps for the kids or myself by the end of the month, and he's been dishonest about our situation. A phone call later with DSHS confirms this.

11/23 - harassed through FB messenger by a Billy York associated with Rainbow Rideshare who is very suggestive in an intimidating way and implying he wants money

11/23 - I sent plates back to vehicle owners in WI. My friend pays to have my vehicle towed to a mechanic she knows and repaired.

11/25 - My children and I connect with DV advocates who begin assisting us.

11/30 - Jim sends me an email with a 1-page scanned copy of what appears to be a mitigation schedule, titled "amicable relations". I don't know what it is and disregard it, telling him in response I'm not interested. I've heard that Jim is moving soon, and place a phone call to see what his plans are or what he wants and check in, but no one answers. I continue to try to work with my advocates and work on the protection packet for the court.

12/2 - pinged by Richelle Burns on Voxer early morning hours. Refused apps request to share location data. At this point, I've changed my passwords as much as I can.

—>It's easy to tell from my bank record what route I'm traveling, where I'm lingering, and that I favor fast food. The incidents I experience align with my bank record.

Describe any violence or threats towards children: _____

He involved Onawa, who was an infant at the time, in a fight where he rolled around on the porch with her and me, biting and hitting me, crushing her under his weight, she was screaming, I tried to get him to stop and I tried to rescue her. It was horrible. However, mostly under Jim's care he neglected her. She would get bad diaper rashes, or get hurt from not being supervised. My daughter Hazel, I'm

ashamed to say, who is autistic, he was the worst to. He would at times grab her by the arm or pick her up by her collar when he was frustrated with her. He said I didn't discipline her enough. That was his excuse. As Onawa has gotten older, he's become more disciplinarian. Her cries or resistance doesn't mean much to him. I think he focuses too much on compliance and being viewed as a weak disciplinarian, to excess. Cold, really. Raven he ignores emotionally. He brought Omawa to a meth house, I discovered, and he brought friends back who were bad, one coming off heroin, and another I caught stroking Hazel's butt. I made them all leave.

Describe any stalking behavior by respondent, including use of telephonic, audiovisual or electronic means to harass or monitor: _____

Jim took my password book out of my purse and I believe he used it to instigate harassment and assault on me when I would leave. A lot of people harassed me over social media for years. For a while, I had a dummy account and was free of it, but then he learned of it, and it started again. They are suggestive that they monitor all my family and friends they know of. That they are nationwide and I have watched many things in the community. They harassed me and advocates at a DV shelter once, after stalking and tracking me down there.

Describe medical treatment you received and for what: _____

I had an MRI after being punched in the head and experiencing bad headaches and problems thinking for weeks after. Another time, I ate a cookie he had left out, and couldn't breathe anymore, threw up and lost consciousness. I just knew that was it, I was dead. The last words I remember were him screaming "what did you eat!?" He never called 911. He left the house. Called my mother in the morning to tell her to check on me. She's the one who found me. He left the children too. I had to be seen at the ER.

Describe any threats of suicide or suicidal behavior by the respondent: _____

After he's hurt me at times, and been made to leave, he's suggested if I don't take him back, he'll just drive himself onto the train tracks. He always expresses how depressed he is. Every time. Afterwards. And also how it's all my fault. What a terrible person I am. A terrible mother. Or psychotic. Or violently abusive. How he's tried, how impossible I am. How something's seriously wrong with me, and he doesn't know what it is, but he's tried. It's all my fault. Maybe he should just shoot himself or I should shoot him. It's terrible. I would never want that.

Yes. This year, when he's angry or been drinking, he began suggesting I wanted to shoot him. I have never said anything like that. I have repeatedly told him I would never do that. More and more, however, he began suggesting he might have to use it against me. It has been a reason why I've had him out of the house after he's started getting irrational and violent, getting physical, etc. I felt it was better for him to be away, the talk did scare me. I have never even touched that gun.

Has the respondent used, displayed, or threatened to use a firearm or other dangerous weapon in a felony? Please describe:

During one of the times he left, he took the gun with him. I learned later from him it had been brought with him and his friends while dealing with one of the men's ex-girlfriend's during a property dispute? I don't know much about it though. I know they'd been firing it off a lot because he didn't have any bullets left.

Is the respondent ineligible to possess a firearm under the provisions of RCW 9.41.040? Please describe:

I really don't know

Does possession of a firearm or other dangerous weapon by the respondent present a serious and imminent threat to public health or safety, or to the health or safety of any individual?

Please describe:

I have felt threatened by him having control and possession of the gun. It's supposed to be for personal protection as a last resort, or to scare off deer or bears. I do feel it's been misused.

If you are requesting that the protection order lasts longer than one year, describe the reasons why: I am disabled. My r-hand is crippled. My daughter is autistic and SSI/special needs. My other two are so little.

I am concerned about not just myself, but my children. I have been blamed for what has happened to myself and my children.

However, I stuck up for myself and my children. Tried to get police to take my reports. Got CPS involved. Tried to introduce counselors and treatment. Everything I could think of I tried. I tried to leave so many times. I was always forced back. I turned to family for support. It was too much for them either. It has seemed no one can help me, there's jurisdictional issues. I have some pictures and evidence, it is spread out in various localities and reports. I recorded a lot in my phone. He's been through my phone.

As well as my personal records. My actual psychological status assigned to me, tentatively, by professionals, is acute stress disorder and PTSD. I cannot take much of any stress anymore. I think it has gone in for so long now that there is enough of a record and otherwise

to support my case. My children I am most concerned with. The people he brings home and associates in our lives to help "manage" us as a family are not only abusive to me, but have not been good for the children, and always seem to be associated with drugs and a criminal element. LSD. DMT. Heroin. Meth. Heavy drinking. I don't like the things that happen to the children or myself.

My children regress, act out, suffer, have cried too much. As have I. We need a chance to heal and not be exposed, harassed, harmed further.

Other:

The children currently seem happier, healthier, like the regression has stopped. I'm seeing a more normal developmental pattern.

More smiles and laughter. I engage my children, give them attention. I don't stick them in front of a TV all the time, I read to them.

At times, we are stressed, there are moments, just filling out the protection order has been a trial. My children act out at times.

We just don't want to be subjected to that anymore. Hazel calls our new place our happy place. She talks about the drinking and more we left behind.

Onawa is soaking so much more. I am NOT a drinker, dealer or drug

user. I don't manhandle my kids. I want a chance for us to heal. He is

DANGEROUS. His ex-wife was targeted her whole life, he never stops.
