Statement from Adam Walter

After sheriff's deputies left the property...

At one point I saw Kathy by the front door with a pistol in her hand. It really freaked me out later when there were multiple people with flashlights outside the rv.

I went inside the motor home to relax. Time passed as the people went to and fro outside and looking at the motor home as the sun was going down.

I didn't think twice and let them go ahead and do what they were.

When night came and I went to sleep a bunch of lights kept shining on the motor home.

And because of the seizure I had after deputies left, I was freaked out because of the lights coming into the motor home all night long and from the yard. So I called for help.

My friend came by, I asked him to stay. But he insisted I come with him. Because he felt I was in danger.

I realized I forgot important things in the rv. We went back and I got a few important things out of it on 2 or 3 different trips that night.

Finally I was too scared to go back for a day or two at a time. We were going to go get the rv but we found it had been moved down the driveway and down the hill. Even though it had been moved without power brakes or steering. There were broken tail lights and a tampered with door lock. Also we saw there were many things taken.

I had Theo help file the complaint. The deputy's wouldn't come. We were told we had to move it and couldn't return it to the property.

While Tad was being arrested and sitting in the car deputies were demanding I move the rv out of the driveway. I told Tad this through the window.
