**Declaration of: Jenna Allred**

1. I am over 18 years old and I am the Petitioner.

2. I declare:

I live in our family home which is in a more rural area of Shelton with our two teenagers.

There is poor to non-existent cell phone reception at home. While I do maintain a land line there, I try to avoid using it as I believe my husband, Rob, who is the respondent, and a skilled IT professional has been monitoring me through both the home phone and the internet service at home. I did change the router out some time ago, as I believe that may be one of the ways that Rob was monitoring us. Rob managed a vacation rental on the other side of a wooded area that is between the two properties. He has the keys to that home and that may be how he has been able to do this.

There is a footpath through the wooded area. There have been a number of disturbing incidents since the first temporary protection order was entered. Several times, I have found what

1 I believe to be human feces in our yard. While I cannot be sure it was Rob, this had not happened  
2 before the temporary restraining orders went into effect. There are a number of other times that I  
3 was concerned someone was outside. This is extremely difficult and anxiety producing for me  
4 because of my reliance on the land line which I believe to be compromised and the fact that since  
5 Rob had to surrender his firearms we have no weapons in the home. This is contrary to an  
6 allegation that was made that I recently purchased a shotgun. I have not purchased a shot gun  
7 but it would probably be a good idea under the circumstances.

8 Prior to the restraining orders, there were two very concerning incidents that I believe Rob  
9 was behind in an attempt to intimidate me. One morning when I went out to get into my car, I found  
10 one of my chickens dead beside my door on the driver's side. The remaining chickens and ducks  
11 were out of the coop and the coop door had been propped open with a shovel. I took care of the  
12 chickens and the door had been closed. Unfortunately, a dead chicken was not the only thing that  
13 I have found beside my car door on the driver side. I have also found three bullets in  
14 the same location relevant to my car door but in town. They were not there when I got out of the  
15 car but they were there when I returned. This was extremely concerning to me and frightening,  
16 and, I believe Rob was responsible for placing them there in attempt to frighten me.

17 In June of this year, I rented a condo out at Westport for a week for the kids and I to take a  
18 break. I saw Rob on the road to Westport. In August, I rented the condo for an entire month, and,  
19 the kids and I were shuttling back and forth at various times. On Thursday August 20<sup>th</sup> at about  
20 12:30 p.m., I reported Rob to the police as I once again saw him on Westport's only road in and  
21 out of the community. As it was the middle of the day and during the work week, I do not believe  
22 this to be coincidence especially as it was the second time.

23 On a number of occasions prior to the restraining orders Rob would get mad at me and  
24 back me into a corner in the kitchen where I could not get away from him and he would yell at me  
25 and get right up into my face. On other occasions, he would scream at me and he would get in my

1 face with his hand towering over me when he was displeased, then walk by or away and slap or  
2 grab my ass with both hands right after having disagreements. These were not friendly butt pats.

3 During the pandemic, he screamed at me for 2 hours because I took his car to get groceries  
4 and I left the "pandemic" groceries in his car. I was accused of doing something to him regarding  
5 the germs on the groceries with the pandemic. So, for the rest of the pandemic I used my car. My  
6 car frequently doesn't start and has numerous strange things happen to it. He refuses to let me  
7 take it to a mechanic and states that he will look at it. But he never does. I have had friends help  
8 me get it fixed.

9 **Wednesday, May 27 2020-** I woke up and stopped by a friends to borrow a tool. My friend told  
10 me about a disturbing social media post my son had made. I came home and discussed it with my  
11 son and believed he had made an error in judgment. We discussed the impact it could have on his  
12 future especially in a small town. He became enraged when I refused to tell him how I knew. I told  
13 him the problem is that he posted not that someone told me. He then took off on foot with  
14 skateboard. He has never acted this way with me before.

15 I called my husband and told him the situation. My husband texted me and told me Robbie  
16 was home and fine. I said how can you see where he is and I can't? This is when I really became  
17 concerned that there was a monitoring device at home. Historically, my husband tracks all three  
18 of us all the time. He tracks all three of our data usages every day. He stalks all social media  
19 posts and makes comments and criticizes anything he doesn't like.

20 We had a heated family discussion that evening, and I thought we should call it a night and  
21 regroup in morning. I knew I couldn't go to bed that night, so I didn't. Increasingly during the  
22 pandemic, I was "falling asleep out by the couch or on the children's floor" so I wouldn't have to go  
23 to bed because I was afraid of Rob. This night I locked myself in our only bathroom with a blanket.  
24 It is the only bathroom in our house and there is a key outside of the bathroom. I woke up in the  
25 early morning to find Rob on top of me. It is very difficult for me to discuss this, but there is a

1 statement that I gave about the incident when I went to the ER for a sexual assault evaluation  
2 days later after the restraining order was served and it is filed concurrently under sealed personal  
3 health care records.

4 Rob has a history of engaging in unwanted sexual touching and acts after our arguments,  
5 I have never regarded this as appropriate or consensual, and, I feel that he should have known  
6 from my body language that I did not want him to do these things. Earlier on in our relationship, I  
7 would tell him no, but eventually, I just wanted to keep the peace and let it go. Rob has always  
8 been obsessed with a variety of anally related sex acts on me, and, even purchased a dildo for  
9 this purpose. I did not like this and eventually refused it. Again, this is difficult to discuss.

10 I have been verbally pressured and demeaned over the years with Rob telling me that the  
11 only thing I was good for was sex and that I was his sex slave if I did not have a job. For a number  
12 of years, I was taking a variety of medications such as Ambien and other prescription drugs for  
13 pain following an injury and for treatment of anxiety. I took myself off these medications a couple  
14 of years ago, but I discovered that there were still some bottles of these drugs in our home after  
15 Rob left in locations that I did not leave them in.

16 I started finding strange bruising on my body for the past year that I had no reason for. I  
17 had been being mindful trying to explain or understand why I had so many bruises. I'd wake up  
18 with pubic hair strands on my body even though I am always shaved due to my husband's  
19 demands. I would have vaginal discharge as well which is common for me to have only after sex  
20 and sometimes even have the smell of latex from condoms that we hadn't used since 1997. I  
21 have had unexplained rectal bleeding on and off throughout this marriage. I generally have a  
22 soda on the counter in the kitchen, while I have no explicit proof I believe that there have been  
23 times when Rob may have drugged me and sexually assaulted me, or, engaged in sex acts with  
24 me when I was not aware of it, such as when I was taking the Ambien and the pain and anxiety  
25 medications.

1 **Morning of May 28<sup>th</sup> 2020.** I woke up with new bruises. I took pictures and then got scared  
2 because I had become aware of him listening in on all my phone conversations with crackling  
3 sounds and making comments about things I hadn't told him. I even did a few tests. I said some  
4 pretty out there things to see if I would hear about it from him and I did. I panicked after I took the  
5 pictures because I realized it might immediately go into the cloud and he would see it. My son  
6 offered to drive me to work so I accepted. Rob and I had had another argument before he went  
7 into the office. It was at this point I knew I couldn't go home again, because I was afraid he would  
8 kill me. Over the years he had not threatened to kill me, but had repeatedly told me that he could  
9 hurt me anytime that he wanted to. I was very concerned that things were escalating on his end  
10 with the stress of problems at work due to a large scale fraud, the pandemic, and, the fact that I  
11 had been standing up for myself increasingly since January.

12 I stayed at my office thinking I'd be safe, but he kept texting me and demanding I call him.  
13 I noticed my computer would not work. He has remoted into it previously. I knew he was watching  
14 everything I did on my computer as well as my phone. I thought I was safe at the office, so I  
15 checked in on my kids frequently. He continued to demand that I call him. I feigned being busy. I  
16 called a friend and had her come and get me. I left the car, my phone and computer at work so he  
17 would not know where I'd gone. I ran to a domestic violence shelter sobbing and scared for my  
18 life.

19 I tried to leave last year and he threatened to take my kids, get me committed, and kill himself.  
20 I had no money, no job, and he tracked every single thing I did or place I went. He has tried to ruin  
21 every friendship, family or otherwise, by saying bad things about them, criticizing them and  
22 making it very difficult to see them.

23 I remain very frightened of Rob and believe that he remains a threat until at least the time we  
24 get through our divorce.
