My name is David Vedder; I am a citizen of the United States and a resident of Washington. I am over the age of 18 and submit this declaration based on my personal knowledge.

I am the maternal grandfather of Mildred Vedder, "Millie". My daughter, Shawnie Vedder, is her mother, and has had mental health problems since she was about 12 years old. She has been institutionalized several times over the years, without success in controlling her illness. There are times were she is better than others, however those moments are seldom long lasting. To my knowledge, Shawnie is currently being treated for "*Schizoaffective Disorder*", and is presently very disturbed. Shawnie is very vindictive, and will go into fits of rage when she is challenged. I fear for Millie's safety and have urged Scott Turchin, Millie's father, to take all precautions necessary to protect my granddaughter.

1 Shawnie is currently married to a man whom I believe has mental health issues of his
2 own. Her husband is not allowed to live in the inside of their home he stays in the garage.

3 Shawnie hates her stepmother, my wife Pam, her half-sister, Shannon, and myself. I have
4 heard her be verbally abusive towards all three of us, and towards Millie as well. Shawnie has
5 also been physically violent towards Pam.

7 Approximately a year and half ago, Pam and I decided to take everyone to the Occan
8 with hopes we could make amends for the family. The weekend ended up a disaster, during the
9 night, Pam and I could hear Shawnie, screaming at Mildred through the walls of the motel. After
10 about three hours of listening to the constant screaming, -we couldn't stand it any more I had to
11 intercede the battle.

12 I fear that once Shawnie hears that Scott has involved an attorney in this matter, it could
13 lead to be out of control with rage. I am extremely concerned certain that this will lead to very
14 serious violence, and I am very afraid that she will take this out on Mildred. I know what
15 Shawnie is capable of and I fear that Mildred could be seriously injured, even to the extent that I
16 believe that Mildred's life will be in danger. I urge the court to get my granddaughter, Mildred
17 out of Shawnie's home before she is harmed.

19 I declare under penalty of perjury under the laws of the State of Washington that the


