Dear Sir or Madam:

Per our phone conversation on 5/22/07 I am writing to request a hearing to ask for permanent allowance of the child tax exemption related to my daughter. Per Ms. Vedders' financial documents she does not have a taxable income. My attorney, Mr. Gooddell, has stated that he cannot introduce that into the current parenting plan modification I am pursuing separately and that it must be under this case number.

In addition, related to another case number (Parenting plan), a deduction of \$10 per month was authorized by Ms Vedder because she did not wish to provide transportation for visitation. I will have the case number and more information available at the time of hearing. My attorney currently has my original copies of that parenting plan. This \$10 was not automatically deducted, as noticed by my attorney, and thus I have been paying that \$10 for the past five years approximately but have provided transportation as requested since the original parenting plan.
