ZOOM HEARING INSTRUCTIONS FOR THURSTON COUNTY FAMILY & JUVENILE COURT

PLEASE FOLLOW THESE INSTRUCTIONS

- 1. How do I attend my hearing?** Court is open during the Covid-19 procedures, but for everyone's safety your hearing will take place using the Zoom video conferencing application. The Court requests that you attend your hearing remotely using Zoom. If you are not able to video conference, you may call in to the Zoom conference telephone number.
- 2. What is my meeting number and call-in number?** Your meeting number and call-in number for Zoom are located on your notice of hearing document.
- 3. What should I do before my Zoom hearing?** You should create a free account and download the Zoom application (www.zoom.us) onto your cell phone or computer. A Zoom account is free. This is not a requirement but will improve your video experience. A cellphone camera or a camera on a computer is needed to participate in the video part of the hearing. You will also need internet access to participate in the video feature of the hearing.
- 4. What if I don't have internet access?** You can attend your hearing through Zoom using just a telephone call. You can also access WiFi hotspots for internet. Free WiFi hotspots are available to the public during Covid-19 at Timberland Regional Library parking lots and hosted by Xfinity (xfinity.com/wifi). Make sure you figure out your internet access plenty of time before the hearing.
- 5. I want the court to consider evidence. How do I do this?** File everything that you want the court to consider in the official court file as soon as possible before your hearing and send a copy to the other party. All paperwork can be filed, including witness statements (use a title page form for each document located here (<https://www.thurstoncountywa.gov/clerk/Pages/forms-available.aspx>)).
