Appellant received the Court's notation ruling issued by Commissioner Jennifer Koh on December 5, 2022, and by way of this letter advises the Court it has remedied and resolved the issued raised in that ruling.

First, Appellant has re-submitted her opening brief, now dated December 7, 2022. A copy of which, along with this letter is being served on pro se, Respondent, Harlan Meier.

Second, Appellant's counsel contacted the clerk of the Superior Court and discovered that both Appellant and Respondent's initial clerk's paper destination, dated September 1, 2022, and September 2, 2022, respectively, were not transmitted due to an owed transmission payment.
