ARRESTING AGENCY AFFIDAVIT

The following occurred in: SHELTON / MASON COUNTY, in the STATE of WASHINGTON

On Febuary 12, 2023 at 0315 hours, Shelton Police were dispatched to a report of gunshots near 1937 Summit Ave, in Shelton, WA. The reporting party stated he heard 3-4 gunshots and then heard "You shot me".

Sgt. Michael DeRoche of the Shelton Police Department arrive on scene into the area. He heard someone moaning and located Elijah Gosset (DOB 12-04-93) on the porch of 638 Arcadia Ave. Elijah was covered in blood. Sgt. DeRoche (per his report) identified gunshot wounds to the chest, arm and face of Elijah. Elijah told Shelton Police Officer Justin Whitley that his (Elijah's) girlfriend, Chantel D. Peterson (DOB 03-14-93) shot him at their residence located at 1933 Summit Drive. Elijah told Officer Whitely multiple times that he was at 1933 Summit Ave when he got shot.

Sgt. DeRoche, along with assistance from the Mason County Sheriff's Department responded to 1933 Summit Drive. The used a loudspeaker to direct Chantel Peterson to come out of the house. When Chantel came out, Sgt. DeRoche observed to what appeared to be blood on her hands and arms. She was taken into custody. Chantel was medically cleared at Mason General Hospital. Chantel declined to talk to me and requested an attorney.

Shortley after taking Chantel into custody at 1933 Summit Ave, Sgt DeRoche and Corporal Rowe (MCSO) entered the residence to check for any other victims. Sgt. DeRoche observed blood inside the house and what appeared to be bullets on the ground in the kitchen. Officer Whitley observed a black semi-automatic handgun with the slide locked opened in a bedroom. Cpl Rowe stated he observed an AR style rifle with blood on the rifle in a bedroom.

At the time of this probable cause declaration, Elijah has been flown to Harborview Medical and Trauma Center in Seattle, WA. A gunshot would to the chest and facial area creates a high probability of death. The RP statement of hearing gunshots, with Sgt. DeRoche's statement of observing Elijah with gunshot wounds and being shot inside 1933 Summit Ave, in addition the observance of firearms inside 1933 Summit Ave show this is an assault with a firearm that has inflicted great bodily harm.
