On 9-15-22 I (Officer J. Lutz) was working routine patrol in the city of Olympia. I was wearing my police uniform and driving a marked police unit.

DISPATCH:

At approximately 2114 hours, I was dispatched a report of possible threats at Capital Highschool (2707 Conger Ave NW).

SUMMARY:

I made contact with the reporting party (Lillian Hunter DOB 7-30-44), the school's principle, over the phone.

Lillian began by telling me that they recently had a teacher, Jonathan Moore (unknown date of birth), fired after an internal investigation regarding inappropriate behavior with a student was completed. She told me their internal investigation had progressed into an open Olympia Police investigation (OPD case # 2022-05131).

Lillian told me that earlier in the evening she had received an email from a school councilor, Jenny Morgan, containing some concerning pictures. These pictures had been found on the social media app Instagram by a concerned student and sent to her. Lillian told me the pictures depicted a shadowy subject and were captioned `12:00 be ready`. Lillian told me Jonathan had been notified he was being fired that morning and was concerned the social media content was a threat to the school.

Lillian sent me screenshots of the posts and I located them on Instagram. The posts were on the account `chs.mysteries`. The page had 4 pictures posted to it`s feed. I did not see a time stamp on Instagram for the posts as Instagram only lists how many hours ago it was posted if it was posted in the same day. I reviewed the photos at approximately 2230 hours.

She told me Jonathan used to show up to the school dressed up, and she believed some of the images resembled how he would dress. She recognized they were not actually him, but believed they were supposed to look like him. All four of these posts appeared to be digital art or edited photographs and did not appear to depict the same subject.

Lillian recognized that the social media profile may not mean anything in actuality, but was concerned of the coincidence of Jonathan being fired the same day these posts were made.

The first post had been posted 10 hours ago and appeared to be a image of a subject wearing a hat, suit and coat with no visible face on a black background. The post had no caption.

The second post had also been posted 10 hours ago. It appeared to be an image of a subject sitting in a chair pulling a top hat his face sitting in a chair holding a cane or axe handle. Across the image were the words `17 reasons why mysterious people` and was captioned `When time comes you will see you all will`.

The third post had been posted 4 hours ago. It appeared to be an image of a hooded subject with his face obscured. It was captioned `None of you are safe. I know your secrets and I assure you they will be aired out.`

The 4th post had also been posted 4 hours ago. It appeared to be a collage of photos of Barack Obama, Joe Biden, and Hillary Clinton. It was captioned `Somethings not adding up...`.

The page also had several `stories` posted to it. Stories are images that are posted to Instagram temporarily and will be deleted after a set time, typically 24 hours.

The first story had been posted 9 hours ago. It appeared to be an image subject wearing a hat and tie `we will be cracking down on the mysteries of the school dms open for any mystery request`. I believed `dms` to refer to Instagram direct messages, and `dms open` to mean the page was taking requests on mysteries at the school.

The 2nd story had been posted 8 hours ago, and was the same image as the first post. It had the words `first mystery solved 12:00 be ready`.

The 3rd story had been posted 4 hours ago, and appeared to be an image of several folders labeled `documents` `crime scene` `evidence` and `suspects`. The image had the words `taking a look at my files... you`ll never know what hit ya 12:00 be there or be squared`.

The 4th story had been posted 2 hours ago, was an image of a man holding a microscope and the words `and so the plot thickens...`.

Screenshots off all the posts and stories were later uploaded to evidence.com.
