Dear Sir: This TSANOV was signed and dated February 24, 2016. Because it was forwarded from my Previous Address it was not received by me at my new address until March 8, 2016. According to the instructions in the Nov letter I have only until March 24, to reply in writing to TSA:

I checked a loaded, small, .22 caliber revolver in my valise at the TSA checkpoint at SKY MESA, a secondary airport in the Phoenix area. My spouse and I were travelling from our home in Arizona (now in escrow) to Washington State to search for a house.

As you may know Arizona is an open carry state. I ordinarily kept the small pistol in my car due to the high incidence of armed assault in the greater Phoenix area.

The day before the incident I had taken my car to Costco to have four tires replaced. I removed the small pistol from the car and placed it in a valise and took the car to be serviced. When I returned home that evening I packed for the next days air travel forgetting to remove the pistol from my valise. I was unaware of my error due to the stress of travel to another state to find a new house.

Sky Mesa airport does not use TSA personnel for security screening as it is a small secondary airport in South Mariposa County. Airport screening is done by Mesa City Police. When the luggage for my spouse and myself was scanned the pistol was easily discovered. The police officer was very courteous and asked me to sit in the screening area while they "ran" a Cl &I". He told his peers it came back, "all zeros." I was not detained and I was not questioned further.

As a retired law enforcement officer from the California Dept of Corrections and a Licensed Clinical Social Worker in both Washington and California, (as well as serving on the staff of Presidents Kennedy and Johnson), I have been in the FBI data base for security screenings since age 19. (I am now 73 years of age.) I told the police officer of my deeply felt embarrassment as I have never had any issues in my personal or private life until that moment.

A few moments later the officer walked my spouse to the parking area and handed the pistol and ammunition to her and told her to put it in our car. When she returned to the terminal we were allowed to board our flight to Seattle without further issue or delay and left on time. Please contact me via telephone or e-mail at your earliest convenience.

You have made me feel responsible and regretful for your leaving Payson.

I miss the man that I knew and loved.

On the night of June 25,2017, when I was cornered in the bedroom by George West who was yelling at me, I asked him to stop yelling. He told me that if he stopped yelling, he would hurt me.

Detective,

George West talked about burning down the house constantly during the months of May and June 2017. After some brush was cleared form the yard, there was a big hole from the original digging of the septic. I was taking rocks from one side of the yard and filling the hole. George West told me around mid June 2017, to quit filling the hole with rocks because he was going to shoot the dog, a 6 month old Doberman puppy, and throw her body in the hole. I took the dog and placed her with Adopt a Pet in Shelton. I realized that the puppy had been taking the abuse directed towards me form March until June 2017. The puppy would run and hide in the other bedroom to get away form George and when she could not and George West continued to yell at her, she peed on the floor or in her dog bed. Prior to my giving away the puppy, George West told me that he, George West, needed to bite his Doberman puppy on the nose to teach her who was in charge.

George West told me that he had a dog with his ex-wife and the dog dug holes. He, George West, had filled a hole with water and held the dog under water until the dog passed out; George West's ex-wife told him he was abusing the dog. George West told me that the dog never dug another hole.

When we moved to the house, A local contractor, Jeff, carn to the house about some work. George West insulted Jeff telling Jeff that he, George West, could do the job better. George West continued to belittle me, Gretchen Jacobs, in front of Jeff. Jeff got in his truck and drove away. Later, Jeff's wife told me that he would not work for George West because of the way that he treated women, me, Gretchen Jacobs.

In November, 2016, George West hired a company to replace the gutters on the home. During the snow, all of the gutters fell off of the roof. I contacted the gutter installer. George West talked to him and threatened him. I was able to work out that the installer returned and repaired and replaced the gutters. It was a very cold day when the installers returned. George West screamed and yelled at me to stand there and watch everything that the installers were doing. George West did not come out of the house because, he, George West, was going to lose his temper. George West locked me out of the house and I feared for my safety. I stayed outside until the gutters were completed. I was cold and needed to use the bathroom.

At least 3 times while in the truck with George West driving, he took out a loaded Ruger .22 from a compartment below the radio in his Dodge truck and pointed the gun at other drivers. George West became angry and aggressive if other drivers were not moving fast enough or changing lanes and going in front of him.

I declare,

I started receiving telephone calls at my home from George R. West on 06-26-2017. He informed me that my daughter Gretchen had packed her things and left without leaving a note. He stated that he was very concerned for her welfare. He asked if I knew where she was going to which I replied no.

Later that day I heard from Gretchen at which time she informed me that she had left due to abuse, was frightened for her life and that George had been arrested. Gretchen then returned to their residence to retrieve the guns that he possessed. Gretchen stated that she had retrieved all but two and took them to the Sheriffs Dept.

Then beginning on the 27<sup>th</sup> I started receiving multiple calls from George. He was crying, Declaration (DCLR) - Page 1 of 3 WPF DV-7.040 (07/2011) - RCW 26.50.130 and stated that he could not handle being in jail. He begged me to try and contact Gretchen, and plead with me to get her to drop all charges against him. I asked George if he had done any of the things that Gretchen had stated, to which he answered that he might have, but couldn't remember. He stated that he had hired an attorney at which time he provided me his name and phone number. I did call the attorney and the attorney requested that

I ask Gretchen to drop all charges, in writing. I did inform Gretchen of the request made by George and his attorney.

I started receiving multiple calls from George on the 28<sup>th</sup>. He was very upset and said that unless Gretchen dropped all charges, he was a dead man because of the things she had said and that he could not go to jail. He stated that he would just kill himself before the end of the month. He continued to get louder and more angry and so I hung up on him.

He continued trying to reach me and I finally stopped answering the telephone.

After receiving his multiple calls, some threatening, and stating that he was going to commit suicide, I have been very alarmed and in fear for my daughter and myself.
