I Identity of the Declarant & Declaration

My name is Michelle Robb, I have lived in Thurston County since 2006, I have three children, and I have been a stay-at-home-mother until 2020, when I started working grocery. Currently I am employed at O'Rielly Auto Parts.

I met Heather Wood in the summer of 2022, when my daughter invited Adeline over for a playdate. Heather would not let her daughter go with anyone, or into strangers' homes without meeting the parents first.

Heather called to arrange a meeting with me so that the girls could hang out to build a friendship. Heather offered the property where Heather and Adeline live in Rochester as a fun place for the girls to play - it has a creek.

My oldest daughter is 14 years old. Keira met Adeline at the skating rink in 2021 when my daughter was only 12 years old.

On the first playdate, the girls joked with me about Heather being so protective: Adeline said: "...but, she means well."

Adeline only visited a few times, including the last day of school in June, 2023.

On July 5, 2023, I received a message in my text inbox from a girl who used to live near my family. Included, was a video posted as: 'Cocaine', showing my daughter snorting a white powdery

substance that I believed was cocaine. Adeline was the videographer. In the video Adeline encourages my daughter to snort the 'cocaine': "do it!".

Adeline's Drug Video Transcript:

Keira:

"Oh my God, I haven't done this in so long."

Adeline:

"Do it. I'm videoing you."

Keira:

"(Sniffs long line of white powdery substance using a dollar-bill-straw)."

Adeline:

"Ahhh, it's that good kinda burn isn't it?" "Ahh, yeah, I did the same thing - yummi. (Long Sniff, short sniff, wipes nose, giggles)."

Heather and I were grieving and racking our brains about what-to-do. Heather said her daughter encouraging a young girl to do such a thing is a life-threatening event: "someone could have died." Heather called the police for an investigation to be done.

The next thing Adeline posted for Keira is that Adeline was emancipated, and [Adeline] thinks she is pregnant.

My daughter, Keira, said Adeline was rude to her, and that Adeline had ended their friendship.

In **late August** Adeline visited us, accompanied by her father after their trip to the Puyallup Fair. First, Adeline entered my home when only my younger daughter and son were home, which is not allowed. Adeline left a giant stuffy for Keira in Keira's room and came back to see Keira later that day.

That same day, Adeline walked up to me in my own home, and looking me straight in the eye said: "My mom is crazy, do not talk to her anymore." I take great exception to this behavior.

Wednesday, **October 10**, **2023**, Adeline prank-phone-called me and said: "I took your daughter's virginity two weeks ago." Adeline has a very distinctive voice. I admonished her ["Is that you, Adeline? F*** You, Adeline"] and hung up the phone.

Wednesday, October 25, 2023, Adeline drove to my house (106 miles round trip) on a school night and invited my daughter into her car for a ride to the skating rink. This is illegal: "For the first 6 months you cannot drive with passengers under the age of 20 unless they are immediate members of your family (such as spouse, child, stepchild, or siblings, both by birth and marriage." (RCW 46.20.075).

I did NOT allow Keira to ride as a passenger in Adeline's car. The girls costumed up at my house, and I took my daughter to the skating rink while Adeline drove herself. Adeline reportedly left the rink to hook up with a guy shortly after entering the skating rink.

On school night **October 31, 2023**, my daughter reported Adeline was skinny dipping in Thurston County's Long Lake (106 mile round trip).
