MOTION

COMES NOW Nancy Tarbell, Guardian ad Litem, appearing pro se only as a Guardian ad Litem, and moves the Court for APPOINTMENT OF LEGAL COUNSEL FOR GUARDIAN AD LITEM. This Motion is supported by the court file and attached declaration.

DECLARATION

I was appointed Guardian ad Litem at county expense for Adeline Feulner by Judge Forbes on October 25, 2023. There have been many filings since that time but no hearings. Matters are complicated. Judge Adams was just preassigned to this cause number and to a companion Emancipation of Adeline Feulner 23-2-01534-18. There are many pending motions in front of the court, many of them very technical and I am asking for appointment of legal counsel to address any future motions. Currently I am spending a great deal of time with my "attorney hat" on and am currently unable to fulfil my GAL duties. This is not in line with my GAL appointment. I am prepared only to act as guardian ad litem for Adeline and am not prepared or willing to make technical legal arguments regarding jurisdiction; the legal ramifications of captioning; the technical aspects of (possibly scrivener's error) changed



1 captioning; and the ramifications of settlement conferences being overseen by a Superior Court
2 Judge.
