DECLARATION

I, Heather Wood, am a US citizen over the age of 18, and a resident of the State of Washington; the facts that I have provided on this form are true.

I am Heather Wood, a committed mother for 16.5 years.

Over the last 16 years, I have reported Lenard for several things and documented in Journals some of these alarming behaviors:

1. Running a skill saw while drunk on Kahlua at his mother's house while holding our infant in one arm to cut a 4x4 post for his mother's mailbox. I had left for only one hour with him in charge, and this is what he said when



I returned to his mother's house: "The first time she cried, but the second time she just stayed quiet and stared."

2. I caught Mr. Feulner showing our daughter playboy magazines – he argued "they are only naked bodies!"
 3. Neglecting to feed the 7 month old Adeline the bottle of breast-pumped milk I had given him in the diaper bag. Lenard never even looked in the diaper bag, and was stoned watching the game all day. Lenard was supposed to have brought my daughter back to the real estate office where I had recently gained employment after passing my test. I had a 3 hour shift, Lenard took her for 7 hours. (Lenard quit work to abandon and avoid the inevitable child support claim by Washington State). I called around twice to all friends, emergency staff and hospitals looking for my baby. I was engorged with breastmilk. I was frantic, in pain, desperate to find baby Adeline. The friend called me from Lenard's mother's house where I could hear my baby screaming. I hurried there. Lenard was kneeling with baby in front of the fridge, as though he might find a pickle to give the baby. The baby became ill and severely fevered in days to come.
 4. Threatening me with kidnapping my child if I ever first, stopped having intimate relationship with him, and secondly, asked for more money in child support.
 5. Surprising us with almost x rated song videos about the way cavemen would have "mated" in a violent, explicit manner. I was appalled at Lenard's lack of inherent judgment and respect for our child's innocence. The disregard and violence for/against women was disgusting in the short seconds we watched.
- a) True to Lenard's threats, as soon as I gave him an invoice to pay for the costs of extra medical bills not covered in 2022, he began alienating my daughter from me, thus producing enormous costs to the Court, damages to myself and most importantly, damages to Adeline.

I love my daughter unconditionally, and I want to get help for her. I want to continue parenting my child in a safe and respectful manner and home.

I have Never withheld visitation from Mr. Fedner.

I declare under penalty of perjury under the laws of the state of Washington and pursuant to General Court Rule 13 and RCW 9A.72.085 that the foregoing is true and correct.
