- 10. prosecute against perjury to the maximum allowed by law,
- 11. vacate all suppression orders on the media that are in violation of the First Amendment,
- 5 12. notify the press (TV and Newspapers) of the order to release all detainees who failed to pay child support from state's prisons by 12/31/2018, and
- 13. notify the press (TV and Newspapers) of the order to vacate all restraining and protection orders
 between parents and their children issued in the absence of equal due process by 12/31/2018.
