I, Heather Wood, am a US citizen over the age of 18, and a resident in the State of Washington; the facts that I have provided on this form are true.

I have mistakenly presumed that Commissioner Clucas granted Mr. Feulner temporary custody of Adeline Feulner on 8/15/2023.

Upon closer scrutinization I now realize Commissioner Clucas did no such thing. I regret the error. Commissioner Clucas ordered Adeline Feulner's residence be with her father - which I took exception to for all the reasons I stated.

Going forward, I would like the record to reflect that I corrected the error I made in arguing Commissioner Clucas granted the father custody of my child.



Temporary residence is not custody, temporary or otherwise.

Moreover, Lenard Feulner also caught this error, which I now concede.

Nevertheless, despite all of the embarrassing-to-me details of this concession, Mr. Feulner has been summarily throwing the Court greaseballs. Mr. Feulner has been consistently telling third parties, relatives, friends, and the Court, that he has been granted custody.
