I have mistakenly presumed that Commissioner Clucas granted Mr. Feulner temporary custody of Adeline Feulner on 8/15/2023.

Upon closer scrutinization I now realize Commissioner Clucas did no such thing. I regret the error. Commissioner Clucas ordered Adeline Feulner's residence be with her father - which I took exception to for all the reasons I stated.

Going forward. I would like the record to reflect that I corrected the error I made in arguing Commissioner Clucas granted the father custody of my child.

Temporary residence is not custody, temporary or otherwise.

Moreover, Lenard Feulner also caught this error, which I now concede.
