Declaration of Heather Wood, mother.

I, Heather Wood, am a US citizen over the age of 18, and a resident in the State of Washington; the facts that I have provided on this form are true.

My name is Heather Wood, the mother of Adeline Feulner.

I was in the hallway of the courthouse after a hearing In RE: 07-3-01713-1 at about 3:30. I was sitting on the bench waiting for a clerk to get back to me about the show cause hearing I had brought to the Court's attention, but had no closing remarks on. I told the clerk I would wait on the bench in the hallway.

As I was waiting, Nancy Tarbell approached me and said she thought she saw a question for her on my face or in my eyes. I had no idea what she could have been talking about, and quickly informed her I did not want to speak with her, or see her again. Nancy sat down next to me anyway even



though I thought I was clearly and precisely adamant I did not want to visit with her.

I clearly stated that I believe she has taken everything I had told her, and twisted it, in order to satisfy her own desire to accommodate the will of my At Risk daughter, however vulnerable, dangerous or irresponsible her choice behaviors have been. I was not whispering like she was, but I was talking in a normal voice and not raising my decibel. I was not pleasing Nancy with niceties, but telling the truth about what I thought of the job she had done as a court's investigator.

I told Nancy that she should have researched the police report and checked the box on her investigation form, which is the law, and I told her that the child Would lie about crime to get her way/freedom/luxuries her rapist supplies, I,E. unsupervised motorhome/ housing, vehicles, weapons and drugs. I told Nancy that she should have investigated further the child's own accusations of her father, as per law.

On this day or tomorrow, I am requesting the video footage of the courthouse hallway to document that I did not encroach her space, but that she chose to sit with me for conversation, even after I told her "no, I do not want to talk to you or see you, and the sight of you makes me consider how icky a person you must be to place my daughter with the man who raped her."

After a long conversation of ~20 minutes (im guessing), she stood up to leave. I stood up and walked down the stairs without another word.



I will continue to try to protect my daughter until death-do-us-part.
