13 THIS MATTER having been brought to the parties and the Court's attention by the
14 Guardian ad Litem, Nancy Tarbell, and the Court inquiring of the parents, the attorney for the
15 child, Kerry Stevens, and the Guardian ad Litem and finding they are all in agreement, and
16 hearing argument from "Amicus Curia" representing that it is a member of the press and
17 somehow arguing the public's right to know opposing sealing a naked picture of a possible
juvenile ,the Court hereby finds:

18 **Findings of Fact**

19 1) that Heather Wood, in attaching a series of pictures to her April 5, 2024 Response and
20 Objections to GAL supplemental report had intended to SEAL both her written statements and
21 the photographs she attached.

22 2) Among the photographs is a photo of a naked female backside. Other photos possibly refer to
23 potentially illegal activity of minors.



1 3) It had been the intent to SEAL all of these documents. Unfortunately, Ms Wood did not
2 wholly carry out that process. Therefore the Kitsap County Clerk's Office did not seal the
3 document or the file.

4 4) The Court determined that the public has no legitimate interest of these photos of minors.
5 Especially in light of the intent of the filing party to seal the documents. It is worth noting that
6 Amicus Curia, acting on behalf of Ms Wood, was instrumental in the filing and serving of the
7 document and photos.

8 **ORDER**

10 The pictures attached to the April 5, 2024 Response and Objections document shall be SEALED
11 *nunc pro tunc* although the written portion of the document will remain unsealed subject to
12 Guardian ad Litem review and bringing the matter back for court consideration.


