## **Exhibit "A"**

### **Parenting Plan, Paragraphs 3.10, and 3.13**

#### **Father must successfully enroll in and complete:**

- **An age appropriate Parenting Class and show proof thereof to the court and to Mother;**
- **A drug/alcohol evaluation by a licensed treatment agency and do whatever follow-up treatment is recommended, and show proof thereof to the court and to the Mother;**
- **Remain in contact with his mental health provider and comply with the recommended treatment.**
- **Father shall sign such releases in favor of the Mother and/or the Court to confirm his compliance with the requirements, where necessary.**

After Father has completed these conditions, and any others set forth in the Parenting Plan, in paragraphs 3.10 and 3.13, he can begin having supervised contact with the child. Visitation shall be supervised by the Mother or by a third party of Mother's choice. The visitation may be up to 3 hours in length, twice weekly on Tuesdays and Thursdays, and will be a location determined by Mother.

Father must maintain a consistent schedule for these visits, so that the child will be able to count on the visit and begin to build trust. If Father misses visitation without good cause, it will be up to Mother to decide when and if visits will begin again, and what precautions will be in the child's best interests.

Father must remain clean and sober at all times. If Mother even suspects that Father is not clean, visitation will be halted and she can request that he take an immediate breathalyzer test, or do a urine analysis test within 24 hours. If the test is clean, then Mother will pay the cost of the test. If the test is "dirty," then the Father will pay the cost of the test. If Father refuses to take the test, then the test will be presumed "dirty."

Visitation may be expanded over time as Mother deems appropriate.

Father shall not pick the child up from school or from any care provider without Mother's express, prior consent.

Telephone contact between Father and Child is encouraged, so long as he is sober and appropriate during those telephone conversations.

Father shall have supervised holiday time for three hours on Thanksgiving and Christmas and Easter provided he is in the same geographical area as the child.

Father shall not remove child from Mother's possession or residence, currently of Kitsap County.

Exhibit "B"

Child's Schedule and Mother's Performance of Parenting Functions.

Child awakes generally between 5:00 and 8:00 am, and spends the next full hour Breastfeeding, eating, and potty, and brushing teeth, and playing. Child is taken for Morning Walk, and taught outdoor-words, and talks with friends we pass on the street. The Child then eats, and plays around the house, and prepares for nap by Breastfeeding, brushing teeth. Child sleeps for two hours, waking midway to Breastfeed, to fall back asleep. Upon waking the Child will Breastfeed again and goes to the bathroom for potty. Mother will potty child every hour throughout the rest of the day. Child continues to eat healthful foods, Breastfeed, drink water, and play. Child accompanies Mother on errands as needed, goes on swimming trips, or visits with relatives. Our Home-Base-Head-Start teacher visits every Tuesday at 1:00-2:30 pm. Child will take another 2 hour nap around 4:00 pm, waking midway to Breastfeed, to finish nap. Child is taken on a second walk to look at the scenery and discuss the day's events. The Child is read to and likes to play and learn around the house before bed. She Breastfeeds, teeth brushed, and goes to sleep. Child wakes several times per night to Breastfeed and get teeth wiped/brushed. Child is taken to the potty at least twice per night.

Mother provides a clean and healthy, smoke free, and a nutritious, and nurturing environment for the child. Mother provides a quiet, safe environment for Child to sleep in, wakes to care for child in the night. Mother Breastfeeds the Child on demand, and takes the Child to potty twice per night. Mother continues to Breastfeed the Child on demand throughout the day. Mother makes all health-care appointments, chauffeurs the Child to and from any and all appointments, purchased/purchases all potty equipment, and bottles, and Breast pump equipment, and any other health needs the child requires. The Mother performs thorough research to provide Child with the best nutritional, educational, and healthful care available. Mother teaches the child sign language, musical instrument, and provides/facilitates Home-Head-Start for Child as well. Mother reads to Child and sings to Child, and teaches the Child languages. Mother researches parenting skills and techniques. Mother takes child on field trips or walks, every single day. Mother teaches Child manners: please, thank you, bless you, etc...Mother bathes child daily. Mother massages Child daily. Mother dresses child appropriately every day. Mother brushes Childs teeth after every meal, as prescribed by Dentist. Mother feeds the Child home-prepared healthful meals every day. Mother keeps child safe from unhealthy additives and foods, such as Mono Sodium Glutamate, candy, cookies, and ice cream, soda-pop, and deep-fried food. Mother comforts Child when she hurts herself. Mother remains attentive to Childs needs, wants and desires all day through
