Petitioner, Kathryn Lorene Stoker, respectfully shows the Court:

- JURISDICTION.** Hans Carl Stoker, a resident of Thurston County, Washington, died on September 2, 2023, leaving property in this state subject to probate administration.
- WILL.** Decedent being of sound mind and having attained the age of majority, executed a document dated July 19, 2022, entitled "Last Will and Testament of "Hans Carl Stoker." Said Will was attested by Cynthia S. Worth, Andrew Worth and Amber M. Saucier, three (3) competent witnesses, who subscribed their names to the Will in the presence of the Decedent and at his request. The original Will has been filed with the Court.
- PETITIONER.** Decedent's Will nominates Kathryn Lorene Stoker as Personal Representative. The named Personal Representative is the spouse of the Decedent

and a resident of Thurston County, and qualified to act as Personal Representative.

4. **BOND**. The Will provides the nominated Personal Representative shall serve without bond.
5. **SOLVENCY**. The value of the Decedent's Estate (including without limitation, the Decedent's probate and non-probate assets) exceeds \$100,000.00 (one hundred thousand dollars), which is in excess of the total indebtedness of the Estate. Decedent's Estate is fully solvent.
6. **NON-INTERVENTION POWERS**. The Estate of the Decedent is solvent, and the Personal Representative was named in the Will. The Decedent's Will also directs that the Personal Representative serve without intervention of the Court.
