She helps them daily with their homework. When with Aurajhia, the boys are always clean, well-dressed and well-fed.

There were times when Michael has historically been an available parent. However, his

involvement as a present and available parent was not consistent. He is also high-strung; those around him have to walk on eggshells around him. Without warning, he can go left-field. When Michael feels that he has been slighted or that he is right, he goes overboard. Despite

times of being a good parent, he has also had times of being unstable to the point of becoming

to attend. As the festivities were running late, Aurajhia called him to let him now that she would be spending the night. Ignoring her insistence that she stay the night, he came to our home well past 11:30 p.m. to retrieve Aurajhia. He was belligerent and wanting to "fight." He attempted to assault Aurajhia and we asked Aurajhia to stay with us and not accede to his

demands but she left with him, letting us know that Michael would not give in unless she left

would him. Her children stayed the night with us. Only when Aurajhia agreed to leave with him,

did he calm down and agreed to leave our property.

On another occasion, I received a call from a frightened Aurajhia letting me know that she was being chased down the street by an angry Michael. We met Aurajhia and her brother at the local Walgreens. Apparently, Michael did not like that she was getting to know her brother and tried to separate them with threats of violence and allegations of incest without evidence; it

Since separation, Michael has called my phone repeatedly from more than one number.

He alleged that Aurajhia was trying to keep the children from him. He ranted about other things. Michael enjoys having control over Aurajhia and uses her boys to further control her.
