I cannot find the other party to serve them. I have made a reasonable search as described below.

Michael Agosto left the State of Washington to avoid being served.

3. Give facts that support your statements in section 2 above:

I attempted to locate Michael Agosto or service. I intended to serve Michael at his supervised visits. When I arranged for someone to be present to serve him, Michael was not present at the visit.

My family reached out to him to ascertain an address when he was in Washington. No address resulted.

I hired a process server to do a skip trace on Michael Agosto. His last known address is located in Whitehouse, Texas but I know for certain that this address is the one that we used to reside in; he does not live there now. Also the process server made attempt at an address located Olympia and Tacoma with which Michael Agosto had a connection but both addresses yielded no positive result.

During March 2025, I saw Michael Agosto in Washington while getting gas with a friend. He scurried away and did not subsequently contact me with regard to this case.

He has not exercised residential time with the children since August 2024 - - a visit for our youngest son's birthday.
