The Assignment to Set Trial Date originally scheduled for 10/03/2025 is cancelled, as a Trial Date has been set on this case.

Case Schedule: Attached is an Order Amending Case Schedule displaying various filing deadlines as well as your trial date which is scheduled for 04/07/2026.

Finalizing by Agreement. You do not need to wait for the trial date to finalize your matter if you come to an agreement before that date. Parties may schedule a Show Cause hearing on the commissioner's calendar at any time to present final orders. If your case is finalized before the scheduled Trial Date, the trial date and status conference will be cancelled.

If neither party is represented by an attorney and a full agreement has been reached, the Family Court Case Coordinator can assist you in preparing your final orders, including the Child Support Order and Worksheets. This service is free of charge. You may reach out at 253-798-8818 to schedule an appointment.

Settlement. If the case has settled prior to trial, parties should immediately file a Notice of Settlement with the Court pursuant to PCLR41. A Notice of Settlement form can be found in the Pierce County Local Rules under Form G. Upon receipt of a Notice of Settlement, the Court will cancel the trial date and case schedule. Failure to enter final orders within 90 days of filing the Notice of Settlement may result in a dismissal of the case.

Requirements for Trial. If your case does move forward to trial, please refer to the enclosed Case Schedule for important dates that you must follow. You should also be sure to come to trial with the following final orders, ready for the judge to complete and/or sign:

- Final Order and Findings for a Parenting Plan, Residential Schedule and/or Child Support (Form FL Parentage 333)
- o Parenting Plan (Form FL All Family 140)
 - o Child Support Order (Form FL All Family 130)
 - o Child Support Worksheets (Form WSCSS Worksheets)

You may not be able to fully complete these forms until after the trial is complete, but you should complete them as thoroughly as possible and bring them with you. The judge may be able to finish them for you during the trial, or may refer you to the Family Court Case Coordinator to finalize your paperwork.
