Re: Order for Protection; Thurston County Cause No. 26-2-30063-34

Dear Mr. James:

On 03/03/2026, the Court entered an Order for Protection. Enclosed is a copy of that order, the Order on Transfer, and a list of treatment providers. You were ordered to complete a Domestic Violence Assessment, a Mental Health assessment, a Substance Use evaluation and to follow the recommended treatment. You must also complete the Impact of DV on Children Parenting Class. I am the Case Coordinator assigned to monitor your progress and compliance.

For treatment, you may use a provider of your choosing; the only requirements are that they are a state-certified provider and that they have contact with Jamie McNear before finalizing the evaluations. The DV assessment needs to be initiated within 90 days of when the protection order was signed, the Mental Health assessment within 60 days and the Substance Use evaluation within 30 days. You will need to sign a release for them to contact Ms. McNear. Please ensure that I am being sent all reports, which must include your case number (26-2-30063-34), regarding your treatment. You may need to sign a release to allow them to communicate with me regarding your treatment. This is the only way to show compliance with your court order.

The parenting class should be completed through Family Education and Support Services. This needs to be completed within 30 days of the order being signed. Visit their website for further contact information at: <https://familyess.org/impact-of-dv-on-children/>
